While there they found a few repair items that aren't under warranty including auto-ejector repair, driver seatbelt retractor, and standard maintenance needed. Total for all repairs comes to \$5,065.45. Roll Call Vote was Unanimous. Preparations are being made to be able to start staffing the station Monday through Friday from 8 AM to 4 PM with two people. We anticipate being ready to start on June 1, 2024.
